Motion passed with Jim Phillips, Paul Vandegrift, Josh Brown in favor and Jon Peasley and Clint Giberson in Opposition. Immediately after, a motion was presented by Jon Peasley to place Josh Brown on administrative leave for not following policy as a board member.. A small amount of comment was made by Jon Peasley and a vote was taken with Jon Peasley and Clint Giberson in favor and Jim Phillips, Paul Vandegrift, Josh Brown in opposition. Before the motion was closed Jon Peasley insisted that Josh Brown did not have the right to vote because the allegation was against him and that Jim Phillips was also not allowed to vote due to the fact he is the president of the board. A Point of order was made by Craig Sauers that all members have a right to vote and that an elected official can only be removed from office by a recall. Two points of information were made by David showing the board the policies that concern motions and voting as a board. At this time Clint Giberson excused himself to retrieve the policy book. After some discussion was had on policy and if Josh Brown was an elected member of the board, it was decided to have a revote with a roll call vote taken with Jon Peasley and Clint Giberson in favor and Jim Phllips, Paul Vandegrift, Josh Brown in Opposition. Motion failed. After the financial and minutes were reported, new business continued with discussion on the failing pump on Brush 42 Christian commented that this is the second pump that has failed with low hours and he would help figure out some options to getting the truck back in full service. It was also noted the audit company will be here on 8/7 to start the 22/23 audit process.continuing with new business Clint started discussion on moving the last meeting of the month to the last tuesday of each month to forgo "late fees on the credit card" Clint made a motion to move the last meeting of the month to the last tuesday of each month and to update the policy manual. Seconded by Paul, the motion passed unanimously. Lastly discussion was had on fixing the reader board sign, Brad and Joe said they would donate time and material to fix the sign and get it fully operational.
